

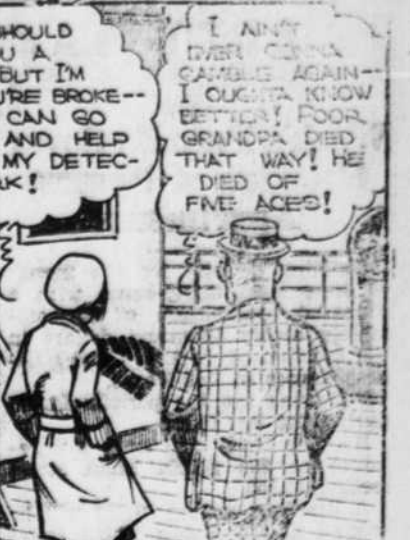
COP CLEARED IN DEATH CASE
