
The town is fairly well divided in support of the two sides to the controversy. Factional feeling is running high. Moreover, the friendly relations between Las Vegas and Boulder City which we have been studiously cultivating are, at the least, somewhat disturbed.

Unfortunately there are such factional differences in this city and so many conflicting reports being circulated that it is well nigh impossible for the general public to judge what is true.

The Age suggests that the department of justice owes it to the government and to the people to make a full, complete and unbiased investigation of the case and place the blame where it properly belongs. We say department of justice, because local peace officers are not working in harmony and the case is being treated as a political issue instead of as a matter of justice.

There are forces working in Las Vegas which will cast discredit and doubt on any verdict a jury might return. In justice to all interests concerned, it is hoped that the department of justice will make a complete and unbiased investigation and tell us just where the fault for this unfortunate situation lies. 

## HOOVER WINNING FIGHT

**P** RESIDENT Hoover is winning the fight for a balanced budget and for a two hundred million dollar reduction in the expenses of the government.

News came over the wire last night that the leaders of both great parties have decided to listen to the plea of the President for prompt action and are now working together to secure results.

The President's appeal to the people of the United States the other day met quick response and approval. Smouldering public resentment at the actions of congress flared into criticism which quickly brought the warring congressmen to a realization that the interests of the people of the United States are paramount to their own petty political quarrels.

Hoover, fortunately, has the courage to speak up when it is necessary and the people have that confidence in the President's judgment which compels quick action.

Congress has shown a disposition the last two days to formulate and pass legislation along the lines of the President's repeated suggestions. Their apparent desire to get results is already producing good effects.


