ANOTHER DR. COOK

I OHN HUGHES CURTIS has achieved the notoriety of a second Dr. Cook as a hoaxer of the whole world.

Curtis deserves the fullest contempt which an outraged people can put upon him. And if there is any law by which he can be sent to prison for a good long term he had better be sent up.

At that Curtis is not such an uncommon type. His chief weakness is for newspaper mention. We see such characters frequently. In fact, we know certain ones who make it their first care on arriving in a city away from home to send for the reporters and tell all about who they are in the hope that they may get their name in the paper.

Publicity comes fast enough and naturally when one has done anything worth publicity. But when it is sought simply because of personal vanity it falls flat.

Conversely, railroad stocks were held in check on the rallies and showed down on declines by the carloadings report for the week ended May 7, showing a drop of 20.335 cars. Atchison and Union Pacific led the reaction in carrier shares, both closing off 11, points. Steel led the market higher on a noon rally and at one time in the session sold at 29%, up almost 2 points from the previous close. The premier industrial closed a point higher at 28 %. Similar price movements occurred in American Can, DuPont, Bethlehem steel and General Motors.

"Agricultural stocks" such as J. I. Case, Sears Roebuck, Harvester and others were sustained by strength in wheat prices, although the grain lost some of its gains for the day and closed with but small advances.






