

DEMOCRATIC TROUBLES

OUR FRIENDS, the Democrats are just entering upon their troubles at Chicagotroubles much more serious than those confronting the Republicans.

As to candidate, the Republicans (as well as a vast number of Democrats) believe that Hoover is the outstanding figure for a presidential candidate, and his nomination was little more than a ratification of a popular choice long ago settled upon.

As to the prohibition question, the Republican convention was divided and the debate as to the form of plank to adopt was ardent. On the one side were those who, while not satisfied with the working of prohibition, believe that it is possible to so modify the plan as to give a certain degree of self-determination to the states and throw the protection of the federal government about those states who desire to retain prohibition. On the other side were an active minority of the delegates and the blatant thousands of the galleries, trying to stampede the convention titanic struggle, the Democratic national into voting for a repeal plank.

The Democratic problem is even more serious than was the problem of the Republicans. The Democrats must not offend the dry south under penalty of losing the nucleus of strength about which they hope to group other states to achieve party victory. They would like to placate the wet forces of Baker, Garner, McAdoo-who knows-even such great cities as New York and Chicago

with a repeal plank, but, knowing that the repeal of the eighteenth amendment means simply a return to the old saloon control of local, state and federal government, they hesitate to offend the millions of voters in the dry states.

So it is probable that next week after a convention will adopt a modification plank with some kind of local option plan similar to that in the Republican platform.

But, the candidate?-that is the question? Roosevelt and Smith are fighting each other bitterly. They probably will be able to eliminate each other, in which case it may be 'Hearst?
