M ORE THAN one-half of all business in Clark county is sustained by tourist trade. Unless we are able to keep tourists coming at the present rate, a large proportion of our business will be considerably damaged, or will fail, and values of taxable property will materially decrease.

During 1931 we had approximately 190,-000 visitors. 1932 promises us an increase because of the Olympic Games and many conventions in southern California. Unless extraordinary effort is made, 1933 tourist travel will not continue at the 1932 level because of the lack of major attractions in California such as are being held this year.

Business from Boulder City, unless something unforseen can be done or happens, is not expected to increase within the next year.

Considering the facts just stated, it has been realized that our community must exert united effort if we are to maintain our present prosperity. With such an endeavor in mind, the Las Vegas Chamber of Commerce has moved to new offices better fitted to serve the city's visitors and plans to spend much time in cultivating a real tourist trade.


