Mussolini holds his power because he has taken the people into his confidence and he depends upon his leadership of public opinion more than upon any display of ruthless power. Hitler seems to have started his own power toward eclipse by his lack of human understanding and tolerance. He might have been a great ruler had he developed his talents as a leader instead of depending entirely upon the mailed fist.

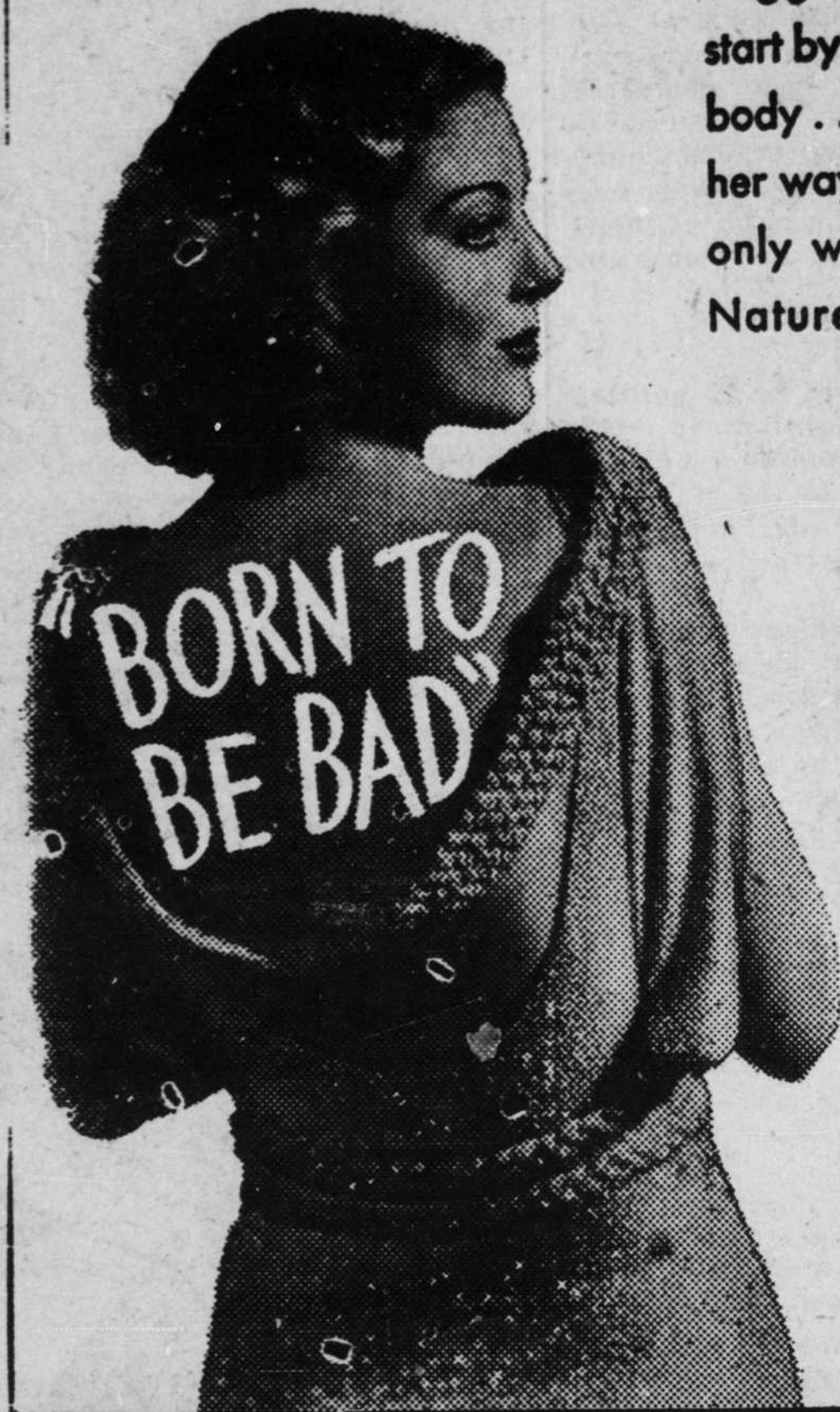
