Report Given Rotary Club

Marion Earl presided at the meeting of Las Vegas Rotary club Thursday for the first time since he was made president of the club.

The meeting was devoted to a most interesting report on the recent convention of Rotary International at Detroit, at which 7,500 delegates were present from 43 countries.

The city of Detroit and its automobile industries did much to make the stay of the visitors pleasant among other things keeping 750 new automoblies with drivers at the service of delegates at all times.

Speaking of automobiles, President Earl said that he decided to buy a new Ford sedan and spoke to a dealer about it. The dealer said, "Would you like to see your car made?" So he was taken to the assembling plant and followed the assembling of his car beginning with the bare frame, through all the processes of the long line, and at the end of the line got in his "new car" and drove away.

According to the report, the only unpleasant incident of the great convention was the address of Postmaster General Farley which was described as a partisan political address, devoid of tact and offensive to members of the large foreign delegation.

RIVER FLOW DIMINISHING

The water shortage in the Colora river is becoming serious, it was revealed today by a report from the bureau of reclamation, which revealed that the river had dropped another 50 feet.

At Bright Angel, the report showed 2,400 cubic feet per second flowing down the river and within 24 hours there was but 2,350 cubic fee. This is compared to normal, for this season of the year of 20,00 cubic feet.

McCLELLAN DEATH IS SAID TO BE NATURAL

The coroner's jury which investigated the circumstances of the death of Clifford CcClellan found that McClellan died as a result of natural causes, "deceased having passed away in bed in his apartment in a local rooming house."

Dr. Roy W. Martin, after examination of the body, found that there was no evidence of foul play.

Funeral services for McClellan were held at the grave in Wood-lawn cemetery at 5 o'clock Wednesday afternoon.

Buehler, of Pioche, as chairman.

The Lincoln county men in presenting their case, called attention to thefact, not yet generally recalized, that the Pioche district has already in sight or partially developed the greatest tonnage of ore of any district in America, mostly (Continued on Page 16)
