REQUIREMENTS ON LOANS TO MINING COMPANIES EXPLAINED

In a letter written July third to Hon. C. B. Henderson, member of the reconstruction finance corporation, Congressman James G. Scrug ham, wrote as follows, in the effort to make clear the act of congress authorizing loans for development of mining properties:

"In accordance with your request, I am presenting herewith my interpretation of Sec. 14 of the industrial loan act, Public No. 417, 73 Congress. This section, which was drafted by me and inserted in the bill by the house banking and currency committee, upon my motion reads as follows:

"The reconstruction finance corporation is authorized and empowered to make loans upon adequate security, based on mineral acreage to recognized and established incorporated agencies, individuals, and partnerships engaging in the business of mining, milling, or smelting of ores.'

"In drafting this section, I follewed in general the language of the present Sec. 13 of the Act, the section which authorizes the reconstruction Finance Corporation to make loans to incorporated managing agencies of farmers' co-operative mineral rights pools, and if there is any ambiguity in Sec. 14 it is due to this fact.

'My interpretation and, according to my understanding, the :nterpretation of the committee, of some of the words of Sec. 14 is as follows:

" 'Incorporated agencies' is to be construed to mean nothing more or less than 'corporations.'

"The phrase 'recognized and established' is intended to modify all three categories of borrowers, incorporated agencies, individuals and patnerships, and is to be interpreted to mean that the business of mining, milling or smelting of ores in which the applicant is engaged must have been established at such time prior to the application that such business shall have obtained recognition in the busines world.

" 'Adequate security, based on mineral acreage,' means that any loan made under this section shall be secured primarily by reserves of ore, proven as to quality and grade. 'Mineral acreage' shall be determined by an adequate amount of development and by at least a partial blocking out of ores in the acreage on which the loan is based.

"The word 'ore' is intended to taining one or more metals of me-

"I shall be glad to be of any further help that I can in interpreting the intent of congress in connection with Sec. 14 or in working out its administration."
