He has accomplished all that has been done in behalf of silver and is today the only man in the United States with sufficient knowledge of the subject and sufficiently close in contact with President Roosevelt's administration to be able to get results.

The people of Nevada should not and will not be disloyal to the man who has accomplished so much for Nevada.

In Tents

Eight tents costing, it is estimated, \$5,000 will be erected on the grounds of Clark county high school adjoining the ruins of the building destroyed by fire last May. At this late date after more than two months have been wasted in an apparent effort to jockey the taxpayers into believing that a new site should be secured and a great new school building erected, the money to be provided by a brand new \$200,000 issue of bonds, temporary structures only can provide necessary rooms for the Junior high at the opening of school.

For many years we have had two school boards, the grammar school board and the high school board, composed of the same persons operating in complete harmony and spending the taxpayer's money just as the whim of the moment impelled. In the early years we had the high school occupying space in the grammar school building. Later the old high school (the one destroyed) was built and occupied and operated for high school purposes. Then when that building became inadequate, the present high school plant was built on another piece of ground and the grammar school permitted to occupy the old high school building with the Junior high school grades.

Suddenly we find the old harmony between the two boards (both composed of the same identical persons) entirely dissipated and the members of each board peering at themselves as members of the other board with suspicion and distrust. They are apparently unable to decide whether they should wag their tails up and down or sidewise and threaten to bite themselves in either case.

The ordinary citizen cannot avoid the conclusion that the present situation whereby it is necessary to spend \$5,500 for temporary tent school rooms, could have been avoided had the board been willing to adopt the obviously sane and sensible policy of using the insurance money to provide the necessary accommodations on the old foundations. Although we have been told that it is impossible to use the old foundations because of the city building ordinance, we are informed by what we consider better authority that there is no reason whatever why the old foundations cannot be used.

The present unfortunate situation arose, it appears, through the desire of the board to find some reason why they could not rebuild with the insurance money, rather than through an effort to "temper the wind to the shorn lamb' 'and lighten, as much as possible, the load upon the backs of the taxpayers.

Under present economic conditions it is folly to expect the taxpayers to vote another school bond issue, especially in view of the fact that the school board has on hand about \$75,000 of money received from insurance on the destroyed building and contents. Fifty thousand dollars will now provide eight fine classrooms, gymnasium, assembly hall and all the necessities for the pupils we expect to have during the next several years. The balance of the insurance money is ample to equip the building. A sincere effort should be made to carry this plan out promptly.

Hitler Names Emissary


