

## Large Audience Greets Senatos

A crowd estimated to number between two and three thousand persons filled the court house lawns and the sidewalks about the block last evening and gave close attention and enthusiastic applause to Senator Key Pittman who spoke from the court house steps.

By means of a loud speaker installed for the occasion the voice of the senator was carried clearly to all portions of the great audience, which, Senator Pittman stated, was the largest gathering which he had ever addressed in the state of Nevada.

Directing his attention principally to the silver issue, Senator Pittman recounted briefly the various steps of legislation which led, finally to the passage of his own bill and the establishment of the United States Treasury's silver policy by the direction of President Roosevelt. In decisive sentences Senator Pittman predicted that the price of silver, already advanced from its low of 25 1/2 cents per ounce less than two years ago, would reach its parity of \$1.29 per ounce within the coming year.

He also called attention to the fact that, by reason of the advance in the price of silver resultant from the legislation introduced by him and passed through his efforts, four thousand men, a year ago idle and destitute, are now employed in the mines of the state.

Senator Pittman also discussed briefly the long and strenuous campaign in behalf of the Boulder Dam project, recalling the fact that in 1921 he introduced the first bill providing for that project and that he also introduced the bill which later in the largest and best concert became a law, making it possible to bring about the compact between the states of the Colorado river basin which resulted finally in the Six State Compact and the passage of the Boulder Dam project act.

Senator Pittman gave generous credit to the people of Las Vegas and Clark county for their support of the Boulder Dam movement over a period of ten years or more, and to Ed. W. Clark and C. P. Squires for their long services in behalf of the legislation.

Preceding the Las Vegas meeting, Senator Pittman addressed a great audience in the open air at Boulder City. The crowd there, as in Las Vegas, gave every indication of being in enthusiastic accord with the speaker and strong in its determination to return him to the United States Senate.

Following the meetings Senator and Mrs. Pittman left at 9:40 for Mexico where Mexican officials have planned to present the Senator with a great silver plaque, the metal for which was donated by the silver in recognition of Senator Pittman's half of the white metal.
