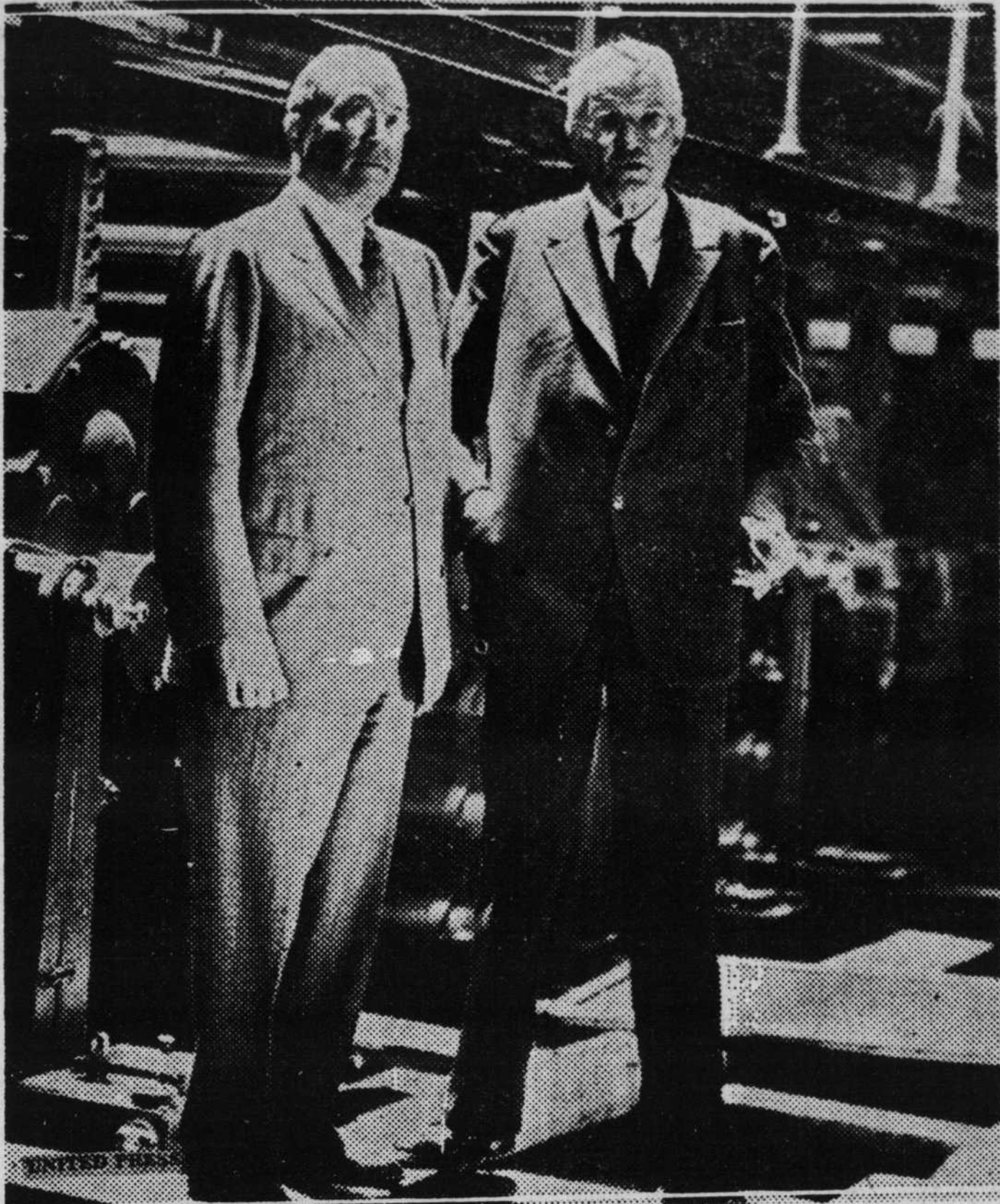


There is no substitute for brains and hard work makes a mighty fine traveling companion.
