

## VOTERS OF NEVADA:

For many years it has been my ambition to become a member of the Supreme Court of Nevada, my native state. In this statement it is my purpose to place before the electorate of Nevada a brief summary of my education and experience.



My nineteen full years of school training began in the public schools of Nevada (8 years), continued in California (6 years), Minnesota (2 years) and New York (3 years). Shortly after graduation from the law school of Columbia University in New York City, the Supreme Court of Nevada granted me a license to practice law.

From the day I entered law school in 1901, until the present time, the law has been the subject of my study and my profession. Two years as District Attorney of Elko county, twelve years as Judge of the Fourth Judicial District, and an additional sixteen years of general practice — such has been my actual experience in Nevada law. In has included many important cases involving the law of water rights, mines, corporations and live stock besides many other branches of the law.

I understand the viewpoint of the general practitioner, the trial judge and the prosecuting attorney because of my own experience in all these capacities.

I am free from hate or bitterness. I feel kindly toward every human being who is loyal to our country and who honestly does the best he knows how. There is no person, be he private citizen, attorney or public official, who need fear that I shall be prejudiced against him.

If elected to this high office, I am prepared to dedicate what I consider will be the best years of my life to the performance of its duties, to the exclusion of all other pursuits, and with a solemn determination to do equal and exact justice, promptly and without fear or favor, to each and every person who may come before me.

### CLEVE CREEK FLOOD STRANDS MANY PEOPLE

Rains that reached cloudburst proportions in a few moments yesterday afternoon washed rock, earth and debris down Cleve Creek canyon completely blocking the road in half a dozen places and stranded a number of Sunday picknickers and fishermen.

Two cars one belonging to Fred Oldfield and the other to Wells Bradley, were trapped in the canyon and could not be moved. Both cars were out of the way of the plunging waters and were undamaged but the impassible roads left the drivers and occupants completely stranded.

Nine persons had to spend last night at Alex Kolcheck's place and this morning four men in the party, Fred Oldfield, Louis Zadow, Clark Oldfield and C. D. Vautrin had to hike four miles down the canyon to get to Clark Oldfield's car which luckily was below the washout. They came into town this morning and then part of the group went back to bring the ladies and children that were members of the party to town.

Bradley and Noel Newhauser remained at the creek attempting to get the former's car through.

The first heavy rain swept over the hills from the west and a few minutes later a torrent swept in from the north. The rain turned to hail and battered down unmercifully.

On the south side of the canyon just above the camp ground where the north fork of Cleve joins in, rain loosened the slag rock and the whole face of the mountain gave way and slid down into the canyon floor. The rocks and dirt block the road at an average depth of several feet for a distance of 40 feet. At numerous other places the road was blocked off in like fashion below that point. The lowest bridge on the creek was washed down stream for quite a ways.

Reports reaching here said that O. L. Johnson and party narrowly escaped death. — Ely Daily Times.

### DEMOCRATS LEAD IN WHITE PINE COUNTY

White Pine county has shifted over into the Democratic party with a majority of 304, a check of registrations for the primary election by County Clerk Fred Oldfield's office has revealed.

For the first time in many years the Democrats have a handy lead with 2011 voters registered under that party. This number compares with 1802 Democrats registered for the last general election in 1932.

The republican total has dropped from 2075 in 1932 to 1707 this year, while the non-partisan register has dwindled from 387 in 1932 to 302 today.

The 1932 figures represent registrations for the general election. After the primaries an increased registration may be expected for the general election this year.
