Opening a Labor Day celebration of two days, the people of Boulder City will start the fun with a program of games, sports and fun generally, at the Boulder City Ball park from 9:00 to 11:30 a. m., Sunday morning. The Boulder City Fire Department are sponsoring the events and offering liberal prizes.

The Rodeo performance will begin at 2:30 Sunday afternoon, at Lorenzi Lake Park. The Las Vegas City band will be on hand to fill the air with music, beginning at 2:15.

The Rodeo, under personal direction of Skeeter Bill Robbins, will include a variety of most interesting events, including the following:

### WHY THE COAT OF WHITE PAINT?

We believe, as a newspaper, that it is the duty of such an institution to place before the people the TRUE FACTS regarding any matter that may effect or jeopardize the best interests of the people of this state.

In past years we have been quite aware of the operations of the "political machine." For many years we have known of the operations of this machine to keep control of our state, county and city government. We have watched its operation and have wondered why the thinking people of our state did not rise up in arms and protest such actions.

During the past few days one of the most flagrant violations of the sacred franchise of the people — to vote for and elect such candidates as they wish to represent them in state, county and city affairs — has been committed — and been given a coat of white-wash by state officials.

We, as a newspaper, state here and now that such a white-wash will not stand uncontested — nor will any of those responsible for such violations escape the full scope of the law. We as a newspaper will, and are now demanding, a full investigation by the federal department of justice.

On Thursday night, Julian Thruston, assistant attorney general told the writer of this article that "he would block any investigation by the department of justice." OUR ANSWER TO THAT STATEMENT, JULIAN THRUSTON, IS THAT YOU WILL NOT BLOCK ANY INVESTIGATION THE PEOPLE OF THIS STATE WISH TO MAKE. Your statement to the writer of this article that "you would wire Senator Pittman and would stop any attempt to have an investigation by the department of justice made" is another place where you have spoken unwisely. Senator Pittman is not the type of man to stoop to such actions as have occurred in Boulder City — for the gain of a few votes in an illegal manner.

Your statement, Julian Thruston, that neither the governor of this state nor your superior officer, attorney general Gray Mashburn, would permit any further investigation, is another place where you have erred. Neither Attorney General Gray Mashburn nor the governor of this state, Morley Griswold, would, nor will they, permit any such whitewash of such conditions as have existed in Boulder City in the voting scandal.

The writer of this article was present when it was revealed that "perjury" had been committed. Just why did you, Julian Thruston, then give every unlawful action a "coat of whitewash?"

Why, Julian Thruston, if there were no unlawful acts performed, did you order that all absent voter's ballots be cast out?

The people of this state are interested in fair play — not any such actions as those that occurred in Boulder City.

According to the sworn statements made by Boulder City voters, they were asked by the deputy county clerk, in the voting place, to cast their ballot for Harley Harmon for governor, Roger Foley for district attorney and Fred Jensen for sheriff.
