Mining Aided By Appointment Of Tasker Oddie

WASHINGTON - Additional assurance that the Administration desired a liberal and sympathetic understanding of the financial problems facing the mining industry in its efforts to secure Federal funds for developing worthwhile properties, was evident with the appointment last week of Tanker L. Oddie, former United States Senator from Nevada, as special mining advisor to the Reconstruction Finance Corporation.

Oddie, who was personally appointed by Jesse Jones, director of the RFC, is to work with that agency in an advisory capacity to its board of directors, with a view of bringing about the widest possible cooperation between the RFC and the mining industry.

As president of the Gold Mining Association of America, Oddie, who is credited with the original development of Tonopah, Nevada, one of the largest producers of gold and silver in this country, has been personally active in national mining circles since his retirement from the political field. His new duties will keep him in the West where he will personally examine all mining projects applying for Federal loans.

Key Pittman Wins By Big **Vote Tuesday**

In the primary election Tuesday, Key Pittman, in his race for renomination for United States Senator, led the field in the number of votes cast, being nominated by a majority of nearly 9.000 votes over his nearest competitor. The figures practically complete give:

For governor, Richard Kirman led Harmon, his nearest competitor by nearly 600 votes, with the other candidates following in order, Cooper, Grant, Richards and Sullivan.

Fred Alward did credit to his friends in Clark county, leading his nearest competitor, Kunz, by nearly 4,000 votes, in the fight for the democratic nomination as Lieutenant Governor.

For mine inspector Matt Murphy won by nearly 6,000 and Gray Mashburn for Attorney General won the democratic nomination by more than 4.000.


LEAVES ON VACATION
