#### OHIO MINE INSTALLS 100 TON CYANIDE PLANT

GOLDFIELD - The Ohio Mines company, owners of what has been pronounced by a number of mining engineers as valuable property, is erecting a modern 100-ton cyanide plant on its holdings at Goldpoint.

General Superintendent Sidney Harris this week announced that the work is well under way, and that the company has purchased two 200-horsepower Atlas Imperial Diesel engines, which will be connected direct with Crocker-Wheeler generators. These big power units now are on the way.

The plant is being set up in the company's old mill building, and all equipment is to be of the latest type.

The company has finished its water shaft, located in Lida Canyon, and will have all the water needed. A pipe line, four inches in diameter, is being constructed, and will have a length of ten and one-half miles.

The plant is expected to be in operation by December 1, and when in operation will employ three shifts, giving continuous production. Officials of the company are jubilant over the fact that the services of Albert Silver, acknowledged as the best metallurgist in southern Nevada, have been secured. Silver will act as consulting mettallurgical engineer.

According to Harris, 100,000 tons of ore running from \$15 to \$18 per ton has been blocked out, all of which is ideally adapted to cyaniding. The ore carries silver and gold in the ratio of eight ounces of silver to one ounce of gold. It is said that in a number of tests records show 98 per cent recovery.

The company plans to continue sinking the main shaft while taking out ore for the mill.

Ofto A. Dieckmann of Cincinnati, secretary and treasurer of the Ohio Mines company, is on the ground ands will remain until the mill is completed and in operation. H. M. Povenmire of Ada, Ohio, a director, recently visited the holdings and expressed himself as well pleased with progress and prospects. He was accompanied by his brother.

Ten to fifteen men are employed at present, and this force will be increased from time to time.


# Bartenders Meet
