Shrine Party Biggest Event Next Month

One of the greatest parties the Knights of the Mystic Shrine on the Pacific Coast have ever enjoyed will be the conferring of degrees and the Shrine Ceremonial in Las Vegas and Boulder City next month, culminating with the Shrine ceremonial at midnight, Saturday, October 20th, and concluding with a great dinner to be served in Anderson Brothers Mess Hall, Sunday morning, October 21, at 1:00.

The ceremonial will be carried out under the most impressive surroundings ever conceived since the building of King Solomon's Temple. The temple will be walled in by the gigantic structure of Boulder Dam, and the towering walls of Black Canyon, roofed by the star studded dome of the sky. The upper coffer dam will be the scene of the ceremonial and preparations are already under way by the Boulder-Vegas Shrine Club to adapt it to the purpose.

Already scheduled are five special trains (probably six) from Los Angeles; two Pullman cars from Mexico; two from San Diego (probably four) and two from Phoenix. One or two cars are being scheduled from the San Joaquin Valley and a considerable party is expected from San Francisco and the bay region.

Reno promises about 350 members who will come by motor bus and automobile. The party will probably include the Kerak Temple band and Shrine Patrol.

There will be at least two bands included in the Los Angeles party, and the Almalaka Shrine patrol. The Los Angeles party will leave Los Angeles about noon, Saturday the 20th. The Union Pacific is prepared to bring them to Boulder City by swift schedule in plenty of time to join in the ceremonial at midnight. Sunday morning the trains will be brought to Las Vegas to remain during the day and will leave for Los Angeles that night.

According to Walter Bracken, member of the local committee in charge of transportation, there will be upward of two thousand shriners here for the ceremonial.

Concert Planned For September 30

Francisco Rozzini, director of the local Musicians Concert Band No. 369, A. F. of M., is preparing to give the music lovers and citizens of Las Vegas a free concert on the court house lawn, Sunday, September 30th, at 4:30 p.m.

It will be the first appearance of the local musicians' band since Labor Day. A real treat is promised music lovers, according to Director Rozzini.

U. P. Prepares to Inaugurate Service Of New Streamline Train Chicago to Coast

America's first Pullman-equipped streamline passenger train is preparing for the inauguration of its operation in transcontinental service between Chicago and the Pacific coast over the Union Pacific, according to Walter R. Backsen, U. P. agent for Nevada.

Its 900 horsepower, 12-cylinder, V-type Diesel engine—the first V-type Diesel engine ever to be used in American railroad passenger service—is capable of pulling the six cars of the train at a rate sufficient to save an entire business day between Chicago and the Pacific seaboard.

The new six-car train is very similar in design to the first three-car streamline passenger train in the world, completed by the Union Pacific last February and which, after its successful 13,000-mile tour of the United States, was taken to a Century of Progress in Chicago, where it became one of the principal attractions. Almost 2,000,000 persons have inspected the train at the fair.

The Union Pacific's second streamline train, like its predecessor, is constructed of aluminum alloy and is of the same exterior and interior design. It consists of a power car, a mail-baggage car, three Pullman sleeping cars and a coach-buffet car, making the total of six cars. The first train, of three cars, has the power plant and mail and baggage compartments all in one car. The other two cars consist of a day coach and a coach-buffet.

The Union Pacific's first streamline train weighs 95 tons and the second weighs about 200 tons. A conventional six-car steam train, comprising engine and tender, steel mail-baggage car, three standard steel Pullmans and a steel coach-buffet weighs about 700 tons, over three times the weight of its modern aluminum alloy counterpart.
