Six Companies yesterday were made defendants in a suit for \$77,700.00 as the outcome of alleged injuries received by Clarence Charles Mendall while working on the Boulder Dam project.

In the suit, which was filed by Attorney Harry Austin, Mendell charges that while working for Six Companies between the dates of June 20, 1932 and April 18, 1935 in the tunnels of the project he was disabled from the fumes of monoxide gas. Mendell asks \$50,000.00 general damages, \$25,000.00 punitive damages and \$2,700.00 for the loss of his time. Mendell was a truck driver on the work in the tunnels.
