Clark County Game Laws **Are Stated**

Game laws for Clark County during the remainder of 1934 which may interest hunters are given below. The open season on sagehens closed August 26, and on doves September 30.

Dates for open season on other game are as follows:

Deer, October 7 to November 5, inclusive. Deer, Lincoln County, October 7 to 22, inclusive. Nye County, October 7 to 21, inclusive. Vater Fowl, October 1 and 2, then season reopens Oct. 6 to Jan. 6, on Saturday and Sunday only — 15 weeks, bag limit being as shown below.

Valley quail, November 4 to Nov. 18, inclusive. Lincoln County, November 4 to Nov. 18, inclusive. Nye County, November 4 to Nov. 18, inclusive. Mountain quail, November 4 to Nov. 18, inclusive; Pheasant and Grouse. November 4 to Nov. 18. inclusive. Cottontail Rabbit. November 4 to December 31, inclusive. Mountain Hare, November 4 to Dec. 31, inclusive...

There is no open season on the following: Mountain Sheep, Mountain goats, Antelope, except as permitted by commission; Elk Does, Fawns, and Spike Bucks, Beaver, Swans. Wood ducks, bitterns, little brown and sand hill cranes, Crebes. Culls, Herons, Loons, Murres, Bandtailed Pidgeons, Terns, and all other birds (except Wilson's Snipe or Jacksnipe.)

Hunting and Fishing License rules vary: Resident citizen of Nevada, Hunting license \$2.50; Fishing, \$1.50; Non-resident, American citizen, Hunting \$10.00; Fishing
