LIEUTENANT GOVERNOR

MRS. ARENTZ

For State Treasurer, Mrs. Harriet K. Arentz, widow of the late Congressman, Samuel S. Arentz, seems, by reason of her wide acquaintanceship over the state, to have the lead over Dan Franks of Lincoln county. Mrs. Arentz has been somewhat handicapped during the campaign by the illness of her small daughter which kept her at home for a time. It is noticeable that the women of the state are throwing their support strongly to Mrs. Arentz.

CONTROLLER

Ed Peterson, thoroughly experienced in the work of his office, is making a very strong showing in his campaign for reelection as State Controller. His wide acquaintanceship throughout the state is also an element of strength. Henry C. Schmidt is making his first flight into state politics. His friends know him as a man of fine character and ability, but he obviously has a hard row to hoe in his efforts to defeat Ed. Peterson.

CLERK OF THE SUPREME COURT Mrs. Eva Hatton, candidate for reelection as Clerk of the Supreme Court, has made a most excellent record for herself during the last four years. She has the support of the legal fraternity because of their appreciation of her ability in that particularly exacting position.

Key Pittman, whose election to absence from the state, rather lost his party, although twenty years ago when he was secretary of state he was considered one of Nevada's most clever politicians.

ASSEMBLYMEN

There are three able Republican nominees for the Assembly, to which four representatives from Clark county are to be elected. They are Harry E. Miller of Las Vegas, and Boulder City.

The democrats, by reason of their overwhelming preponderance in numbers of registered voters, confidently expect to elect their four nominees. It is quite probable, however, that political affiliations will be largely disregarded in the election of assemblymen and that the delegation as elected will comprise two Democrats and two Republicans. Harry Miller the only Republican nominee for the assembly from Las Vegas is conceded an excellent chance for election. Boulder City voters in all probability, will concentrate upon one or the other of their republican nominees.

Raby Newton, Dick Arnold, Ambrose Murphy and Raby Newton, the four Democratic nominees for the assembly are all working hard, each determined to be in the list of victors November 6.

COUNTY CLERK
