NEVADA FARMERS FAVOR CORN-HOG PLAN FOR 1935

Continuation of the corn-hog production control program of the federal government in Nevada is decidedly favored by the State's pork producers, it is revealed in a referendum just concluded by the county corn-hog associations.

With nearly half of the association members voting, as well as some not connected with the organizations, the state's hog ranchers cast a nearly 10 to 1 vote in favor of the agricultural adjustment administration program for 1935.

Actual figures, according to Professor V. E. Scott, of the University of Nevada Agricultural Extension service, who has been helping the Nevada hog producers in their work, show 124 favoring the control plan and but 13 opposing.

The Nevada pork growers also went on record as approving a onecontract per farm adjustment program dealing with grains and livestock effective in 1936, according to

Scott. Of the ranchers voting, 82 favored the one-contract plan, but 55 opposed it.

The voting was both by mail and by a dozen meetings held by the nine local associations in hurchill, Clark, Douglas, Elko, Lincoln, Nye, Pershing, Washoe, and White Pine counties.
