Stocking the Forest

Through cooperation of Forest Supervisor Gurr with the board of county commissioners, the national forests about Charleston Park and Deer Creek will be stocked with elk.

The animals are to be loaded at Yellowstone Park by the forestry officials and the board of commissioners has to pay only the cost of transportation to Las Vegas by rail and thence to the mountains by truck.


Inasmuch as there is sufficient money in the fish and game fund of the county, which came from the issuance of licenses and which can be used for no other purpose, the county commissioners are to be commended for carrying out the plans for stocking our forest regions with elk. The forests are already partially stocked with deer and a plentiful number of these fine animals will add much to the interest of our forest regions.

One of the important ends gained by the cooperation between the county board and the Forest supervisor, will be the better protection of all wild life in our forests. The federal authorities, it is understood, will insist upon and assist in the enforcement of the game laws. In the past there has been too much disregard of the regulations protecting deer with the result that they have been ruthlessly slaughtered at times. In the future, with the agents of the federal government investigating such matters, we may expect that both deer and elk will be properly protected so that, within a very few years, our forests may be well stocked.
