CARSON CITY—The Union Pacific railroad has notified the Nevada tax commission that it has paid \$100,501 in taxes in Clark and Lincoln counties under protest.

The company claimed that it should have been assessed but \$33,511 in Lincoln county and \$42,457 in Clark county, a total of \$77,969.
