"EL OSO VIEJO"

In Number One, Volume One, of "The Pico Pioneer News," under the heading "The Memoirs of a California Pioneer," is published a thrilling story of Death Valley, "Under the Desert Sun," a true story by "El Oso Viejo."

In another place in that issue I observed the heading, "'El Oso Viejo' Speaks for Himself," under which is printed a letter which interested me greatly because of the name signed. It reads as follows: Pico, Calif., Dec. 24, 1936.

I am introducing myself to the people of this community as an old timer who crossed the plains in 1860 in a covered wagon. I came to Los Angeles in 1874 and having been a 20-mule teamster hauling supplies to the various mines in Lower California and Nevada, I am well acquainted with the development of California and Nevada and will try to present to our readers of the Pico Pioneer News many of the early incidents taken from my diary written at that time.

I am also writing of the conquest of California by Fremont as told to me by some of those who participated in that event. I shall write of the history of Death Valley which will be published from time to time in the Pico Pioneer News.

Now, I am an old pioneer and not an up\_to\_date writer, so I am asking the public to lock with leniency upon the many errors that I shall certainly make.

He it was who took the contract for constructing the first concrete walks in the residence districts, including those on Fremont street between Fourth and Fifth; Fourth street beween Fremont and Stewart, and the west side of Fifth street between Ogden and Carson.

# **Federal Schools**

In compliance with the appeal of Deputy Superintendent of Public Instruction Leonard Sledge at the Chamber of Commerce meeting on Tuesday, a resolution was adopted advocating federal aid to the public schools of the nation.

The Fletcher bill which is advocated by the resolution, would provide a fund of one hundred million dollars as the start, to be increased by fifty million dollars a year until the maximum of three hundred million is reached.

According to Mr. Sledge Nevada would receive about \$59,000 the first year, increasing to a maximum of \$177,000 per year when the maximum amount is reached.

## LAS VEGAS WEATHER

Las Vegas has suffered, in common with the entire Pacific coast and the inter\_mountain region, from abnormally cold weather during the first week in January. The minimum reached 20 degrees above zero last night after the storm of Tues\_ day, Wednesday and Thursday cleared. There was a flurry of snow accompanying precipitation of .33 inches on the 6th and an additional .05 on the 7th.
