

New Gymnasium For University

Entering the second week of a concentrated drive towards a new gymnasium on the University of Nevada campus, the Blue Key National Service Fraternity, which is sponsoring the drive, announced that a bill concerning the new structure will be drafted and presented to the state senate and assembly within the next few days.

A committee of four, led by Walter States, university activity leader, has been conferring with state officials on the best plans concerning the drive towards the new gym, and announced that the outlook for the possibility of such a structure is becoming more apparent.

The drive climaxed many years of dissatisfaction with the present gymnasium, as the students claim that athletic facilities are hampered by the lack of space and that the present gym is not adequate to handle the increasingly large crowds that attend the athletic contests held there. Existing conditions of the gymnasium will be noticed by many athletes throughout the state who will come to Reno for the annual high school basketball tournament on the eleventh of March.

"We have to apologize to visiting basketball teams every year as to the cramped space and sanitary conditions that exist," the committee reported, "and we intend doing all in our power to better the athletic situation as much as possible as an aid to future students at the university."

As the building of this new gymnasium is a definite step towards the improvement of this institution of the citizens of the state of Nevada, the students of the university are desirous of the whole-hearted support of every person interested in educational advancement within the state.

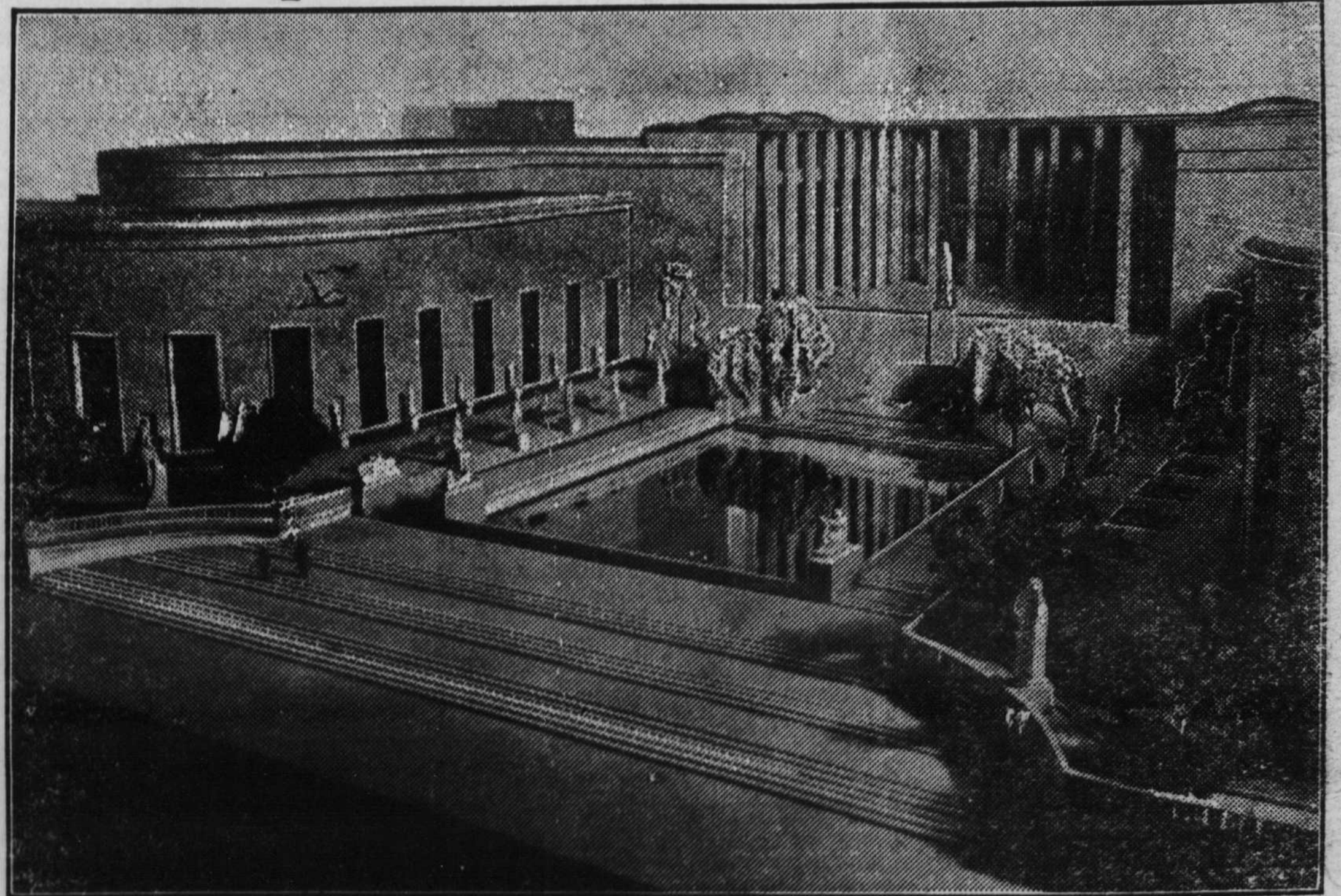

Paris Exposition Building New Landmark



THIS symmetrical building in the modern classic manner is the new Museum of Modern Arts which is being built on the Quai de Tokyo in Paris for the Paris 1937 International Exposition. The site of the building was occupied in the 18th century by a house built by Louis XV for Mme. Pompadour. That famous lady planted in the garden of her residence a

cedar tree which has since figured in literature and history. When the original house was destroyed to make way for another the architects carefully preserved the tree in planning the new structure. The second structure was lately occupied by the Polish Embassy which recently moved to make way for the building of the Museum. The designers of the new building, like their prototypes of the

last century, have so drawn their plans as to continue the preservation of the Pompadour cedar. Into this new museum will be moved the numerous masterpieces of the art of our own times which are now scattered among the Louvre, the Luxembourg and other historic collections. These will at last constitute a coordinated collection in an eminently suitable background.
