judgment, should disagree with the whims or desires of the administra_ tion in office. This amendment fur_ ther provides that the city attorney shall institute, commence, prosecute or defend all actions in which the city may be a party, without that fixed by law. This has not any additional compensation, save been the practice in recent years. The city attorney has been paid a very substantial salary and when the city became involved in litigation special compensation has been granted and paid to the city attorney The municipal judge surely should be elected so that he may be free from any influence and fear of removal without notice by the city This has been commissioners. demonstrated in the City of Las Vegas in recent years when one of our municipal judges appointed by the city commissioners was removed without a day's notice by reason of the fact that he refused to be dictated to by the city commission_ ers and the then city attorney as to the manner in which he should assess punishment upon a certain class of offenders.

My further proposed amendment provides "That the Board of City Commissioners shall publish month_ ly in one of the newspapers of Las Vegas all bills allowed by them, to_

gether with the names of the persons to whom allowed, the amount and for what purpose. My reason for this is that the taxpayers should know how and in what manner the city funds are being expended. I am of the opinion that if these expenditures were known to the public monthly the taxpayers' money would be better conserved. I know that the county commissioners of the respective counties of the state are required by law to publish the county bills monthly; and I further know that there are a number of cities in the state that are required to do similarly.

My further proposed amendment provides "That no incumbent city commissioner shall be eligible for nomination or election as mayor unless he shall resign his office as commissioner before becoming a candidate for mayor."

The purpose of this amendment is to place all candidates for mayor upon an equal footing and to pre... clude the abuse of a commissioner remaining in office using his influence as such commissioner to further his own campaign.

I also proposed a further amend. ment "Permitting the City of Las Vegas to purchasefi acquire and operate municipal water works, power plants and swimming pools." I have always been greatly inter_ ested in seeing that Clark county, including Las Vegas, obtain the greatest benefit from the power generated at Boulder Dam and at the least possible cost, and I want to say that as long as I remain a representative of Clark county I shall strive to the best of my ability to procure all possible benefits from it. Being a life_long Demo_ crat, I feel today, as I have always felt, that the people should rule and that they should procure the things they desire.

In the preparation and introduc. tion of the foregoing amendments I have carefuly studied and have been guided by the many suggestions and requests from a great number of individuals of our county and city, for which cooperation I avail myself of this opportunity of expressing my gratitude. I am sorry, of course that by reason of the arduous duties here in the senate as a member of many comm t. tee assignments, including Judica iary, Education, State Library, Public Morals, Indian Affairs, Military Affairs and Printing. I have found it impossible to reply to the many let... ters, petitions, wires, etc., they have so faithfully sent me. It has been impossible to carry on a chain of correspondence and to attend to the affairs up here as'I know they ex. pect me to do.

The people of the State of Nevada do hereby enact:

W. C. T. U. TO AID

SCHOOL FOR VEGAS

SECTION 1. In order to quiet and subduethe electric tension and the super_static condition of the atmos_ phere of Southern Nevada, and to provide more power for the political lines of that region, the Boulder Dam shall, immediately upon the passage and approval of this Act, be moved to the City of Reno, in the State of Nevada, and there to be in. stalled to serve as a bridge across the Truckee river, same to be known as the Sierra Street Bridge. The work of moving this dam is to be done under the supervision of W. P. A., P. W. A., F. E. R. A., N. I P A C. C. C. and W. C. T. U.

SECTION 2. If it be found that the Dam is too large for the Sierra street extension then in that event part of same shall be used to provide a second bridge across the Truckee river to be known as the Lake Street Bridge.

SECTION 3. In full payment for the perpetual use of Boulder Dam and as just compensation therefor, it is hereby provided that the State Orphars Home now located at Car. son City, Nevada, shall immediately be moved and transferred to Las Vegas, Nevada, together with all buildings, grounds, liabilities, occu-"ants and with all tenements, here... ditaments, and appurtenances there_ unto belonging or appertaining; said Home to be used by Clark County for a Junior College. "One Sound State," listened to vio_ stressed at the one_hour session, so Sinai read the following:

"SECTION 497. No Railroad oper_ ating in the State of Nevada shall run over and kill over seventy (70) cows in any one accident.

"SECTION 2. No engineer operating a train on any Railroad in Ne_ vada shall be entitled to kill more than seventy (70) cows in any one calendar year. Any engineer who violates the provisions of this Section by killing over seventy (76) cows in any year, shall have his cow_killing license cancelled with_ out a hearing before the Cow_Kill_ ing Board, and he shall in addition hereto be fined the sum of Seventy Dollars (\$70.00) for each cow killed over and above the legal limit.

COWS FOR ORPHANS

"SECTION 499. All cows killed by any Engineer on any Railroad in Nevada shall be delivered free of charge by the offending Engineer to the State Orphans Home, after such cows have been skinned, dressed, cleaned and properly inspected for tuberculosis, hoof and mouth dis_ ease, and rabies; said inspection to be made by the State Fish and Game Commission.

SECTION 500. Any cow roaming along the tracks of any railroad in Nevada, which, by chance, may live
