SCHEDULE G

Residential

Effective for Domestic Service
Service: Applicable to all consumers of lighting service and appliance use for general domestic and household purposes.

Rate

First 40 KWH per meter per month, 3.5c per KWH.
Next 40 KWH per meter per month, 3.0c per KWH.
Next 170 KWH per meter per month, 2.0c per KWH.
Next 250 KWH per meter per month, 1.0c per KWH.
All over 500 KWH per meter per month, 1/2c per KWH.
Minimum charge, \$1.00 per meter per month.

SCHEDULE H

Effective for Commercial Lighting Service

Service: Applicable to all consumers of business lighting service, including single phase lamp socket devices.

Rate

First 250 KWH per meter per month, 3.0c per KWH.
Next 750 KWH per meter per month, 2.5c per KWH.
Next 2000 KWH per meter per month, 2.0c per KWH.
Next 2000 KWH per meter per month, 1.0c per KWH.
All over 5000 KWH per meter per month, 1/2c per KWH.
Minimum charge, \$1.00 per meter per month.

SCHEDULE I

Effective for Power Service

Service: Applicable to all consumers of general power service at standard voltages.

Rate

First 50 KWH per HP per month, 3.0c per KWH.
Next 50 KWH per HP per month, 2.0c per KWH.
Next 10,000 KWH per month, 1.0c per KWH.
Excess, 1/2c per KWH.
Minimum charge, \$0.75 per HP of connected load per month, but not less than \$3.00 per month.

Special Conditions: Connected load shall be considered as the name plate rating of all motors installed but in no case shall the total be less than 3 HP for billing purposes.

Whenever, upon test, any motor is found to be delivering more than 125 per cent of its capacity, as indicated by its nameplate rating, the nameplate rating may be disregarded and charges may be based upon the output calculated from test.

SCHEDULE K

Effective for Commercial Heating, Cooking or Water Heating Service Only

Service: Applicable to all consumers of commercial heating, cooking or water heating service only.

Rate

First 500 KWH per meter per month, 2.0c per KWH.
Next 4000 KWH per month, 1.0c per KWH.
Next 10,000 KWH per month, .007 mills.
All over 14,500 KWH per month, 1/2c per KWH.

State Highways Survey Planned

Through the state-wide Planning Survey in cooperation with the United States Bureau of Public Roads, the Nevada Department of Highways has completed preparations for one more phase of its work, according to an announcement made public at highway headquarters this week.

This phase of the work is designated as the Road Use Survey and involves the study of the relative use of the several highway systems of the state, of the various counties and also the use made of municipal streets. The purpose of the study is to determine the use of these facilities made by the various population groups classed as urban or rural in character.

To obtain these results, the Planning Survey Division of the Department will assign to the field a number of specially trained interviewers who will contact, through personal calls, motor vehicle owners of the state. The necessary dependable data can be obtained only through this manner.

The general object of the survey is to determine what use is being made of the highways and streets by those who pay for them.

Accuracy of results depends largely upon the cooperation of the motor vehicle owners interviewed. All information gathered is for official use only and will be held in strictest confidence.

Clear Way For Old Age Relief

The special election designed to clear the way for participation in the Federal Social Security program will be held between the hours of 8:00 a. m. and 6:00 p. m. Wednesday, March 17.

Voters in Las Vegas precincts 1 to 5 inclusive will vote at the fire house. Those in precincts 6, 7, 8 and 10 at the grammar school Fourth and Lewis, and 9 and 11 at the McWilliams garage, West Side. Boulder City precincts will vote at American Legion hall, according to arrangements made by County Clerk Lloyd Payne.

The question on the ballot is on repeal of Section 3 of Article XIII of the constitution of the State of Nevada, which reads:

"The respective counties of the state shall provide as may be prescribed by law, for those inhabitants who, by reason of age and infirmity, or misfortune, may have claim upon the sympathy and aid of society."

Richfield Man Gives Program

Las Vegas Rotary Club at its meeting Thursday noon had among its guests a party of Los Angeles Rotarians under the leadership of L. D. Blodgett, manager of the commercial department of Richfield Oil Company, including Chet. Nelson, Lee Caswell, George Pulford and Ralph Hall, the latter flying the party here in the Richfield ship.

Mr. Blodgett gave a most entertaining talk on the subject, "Fall of a Young Businessman," which he aptly illustrated with an amusing narrative of his own experience as a young man when his loyalty to his employer, operator of a side show, led him to undertake a parachute jump which almost cost him his life.

He defined the three necessary qualities of a successful salesman as follows:

You must have "dollar value" in what you have to sell.

You must know the area in which you can sell it.

You must have the personality of a seller.

Mr. Blodgett illustrated the elusive qualities of personality by reciting the following couplet:

"Consider the jittery jumping flea!
"You can't tell which is a he or a she;

"But they're as happy as they can be,

"For he can tell and so can she."
