#### Power District Deposits Cash

Lincoln County Power District No. 1, at the meeting of the Nevada Colorado River Commission Tuesday last, deposited with the state \$50,000 in cash which was handed to them in the form of a cashier's check issued by the Bank of Pioche.

The cash deposit was made in lieu of a bond for \$50,000 demanded by the commission to cover any possible default in payments for power to be delivered to the district, and is full compliance with the requirements set up in the contract between the District and the Commission.

This is apparently the last step necessary to permit the Commission and the Bureau of Reclamation to deliver power to the district upon the completion of the main transmission line from the dam to the Pioche area, the completion date being estimated at about July

The Pioche District expects to use 5,000,000 KWH per annum of electrical energy from Boulder Dam as soon as power is available, and have plans under way whereby they will use a large amount additional as the mines and ore-treatment plants are made ready for operation.

Mr. E. H. Snyder has been in the east for some time confering with his associates on the plans for beginning construction of large electro-chemical separation plants for the treatment of lead-zinc concentrates in the Las Vegas area.

#### To Operate Mine **Near Gold Butte**

G. C. Mulkern, mining engineer residing in Chicago, is developing a property in the Gold Butte district on the Nevada side of the line between the Rio Virgin and Lake Mead, located about six miles from the lake.

Mr. Mulkern, who represents a group of eastern capitalists, has purchased two air compressors and other equipment and already l.as sixteen men working putting the property in shape for operation. He was in Vegas Thursday purchasing supplies for the camp and seeking ten additional men to work on the property.

Ed W. Clark is spending a ew days in Los Angeles after having attended a meeting of the Colorado River commission in Carson City. He is expected home Sunday.

#### First Meeting In **New Elks Building**

Although only partially furnished, the new building persented a brilliant appearance, and was crowded with at least five hundred Elks from all parts of the country who joined in the jollification attending the opening of the Club House and Lodge.

One hundred and twenty-three, out of the class of almost 150 candidates making application for membership, appeared and went through the initiatory ceremonies in the beautiful new lodge room. It was one of the largest classes ever to join the Elks organization at one time in the history of the state, according to leading Elks who were present.

#### **Making Progress** Vegas Friends On Power Line For Vegas Elks

Following the delays caused by heavy snows in the mountains of Lincoln and Clark counties, work lows: on construction of the main power transmission line from Boulder Dam to Pioche is now progresing rapidly.

H. W. Benecke, electrical engineer of the Lincoln County Power District, and F. O. Broili, resident engineer, and inspector for the PWA on the project, are planning to move their headquarters to Las Vegas.

The line is completed and the cables installed across Highway No. 93 at a point about three miles south of Maynard Lake leaving 90 miles of construction to be done. Because of the more open character of the country the remaining work should progress more rapidly than that through the high mountains near Pioche.

The route of the line will cross the Union Pacific track at Dyke siding and will cross the Salt Lake highway a short distance northeast of the point where the road to the Western Air Express takes off.

Bids were opened last week for the work of erecting the steel tow ers to carry the line over the canyon walls to the switching station for the Lincoln County Power District. The towers have already been purchased from the Bethlehem Steel Company at San Francisco.
