Funeral services for Mrs. Sarah Keele Wadsworth were held Monday last in the L. D. S church in Panaca, with Elder F. C. Lee officiating. The speakers included Elders David Keele, F. C. Lee and Derrill Ronnow. The invocation was by Osborne Lee and the grave was dedicated by Lester Lee.

Pall bearers were the five sons of the deceased, Allen, Edwin, Arnold, Frank and Gilbert Wadsworth, and a grandson, Merle Adair.

Hymns by the choir included "Oh My Father," "I Need Thee Every Hour" and "Sweet Hour of Prayer."

Mrs. Florence Wadsworth rendered a solo, "Dry Your Eyes."

From the Caliente Herald we learn that Mrs. Sarah Wadsworth who died Sunday morning after a serious illness of several weeks, was the youngest daughter of the late Samuel Keele and Annie Elizabeth Hess Keele, Mormon pioneers. The Keeles knew the Prophet Joseph Smith in Nauvoo and left there with the exodus and crossed the continent in the hand-cart train.

Mrs. Wadsworth was born August 31, 1868, in Panaca, where all her life was spent with the exception of five years' residence in Fallon. She married David Wadsworth in Panaca, who passed away about two years ago, and twelve children were born to them to whom she devoted her entire life.

In 1927, while residing in Fallon, Mrs. Wadsworth suffered an illness which caused her to be a semi-invalid the remaining years of her life. She was a patient, cheer ul sufferer and kept house for her two youngest sons.

Surviving are three daughters, Madaline W. Buehler of Bristol, Annie W. Higgins and Ella W. Montgomery of Pomona Calif.; five sons Edwin of Fallon; Arnold of Wamboldt ranch; Allen, Frank and Gilbert of Panaca; twenty-one grand-children and thirteen great grand-children. All of her children were at her bedside when the end came.

Swartz Named State Chairman
