**COPY OF RARE REPRINT OF MASONIC LORE FOUND**

A copy of Franklin's reprint of Dr. Anderson's Constitution of Freemasonry was recently discovered in Los Angeles, Calif., by a local collector of rare editions of that city. The original was printed in 1723, in England. Benjamin Franklin, a Grand Master of the Grand Lodge of Pennsylvania, republished the work in 1734.

Only eleven copies of the Franklin reprint are known to be in existence. One of them, and of the first authentic Masonic work to be published in America, is in the Library of the Supreme Council, Scottish Rite, of the Southern Jurisdiction, at Washington, D. C.
