

## Pioche Power Line Equipment

Transformers and equipment for the substations on the Boulder Dam - Pioche power line arrived in Lincoln county during the past week and have been transferred to the sites of the substations, construction of which is expected to get under way in the next few days.

The equipment for the Gold Springs station, consisting of three transformers and accessories and the Caliente and Delamar stations, consisting of four transformers and accessories for each, arrived in Caliente last Saturday and a crew of men consisting of John W. Cole, Ira Heavin, Richard Willis and George Sullivan have been engaged in transferring the equipment to the substation sites.

Equipment for the stations at Panaca and Pioche arrived the first of the week and is being transferred to the ground so that everything will be in readiness for the start of construction work as soon as the contract is approved by the PWA authorities. The low bid for construction was submitted by Bennett-Taylor company of San Francisco when the bids were opened at Pioche on June 3.—Caliente Herald.

## Missing Plane Fuselage Found

The major portion of the fuselage of the ill-fated Western Air Express plane which went to destruction in the darkness of December 15, was found Thursday where it had been hurled on the slope of Hardy peak, approximately a thousand feet below the summit.

The bodies of the seven occupants of the ship are supposed to be within the cabin and frantic efforts were made to dig away the deep snow which still entombs the plane.

Nearly all of the several hundred pounds of air mail was recovered as well as most of the personal baggage of the occupants. It is expected that the bodies will be uncovered and removed within a few hours.

The work of recovery is attended with great risks and much hardship. Snow and rock slides constantly endanger the lives of the searching parties and it is stated that no attempt to remove the bodies when discovered will be made until safer

## Resort Burned At Steamboat

Fire early Wednesday morning destroyed the sixteen-room resort hotel at the famous Steamboat Springs located about ten miles south of Reno, on the Carson City highway.

The bath house nearby was not burned, but the valuable furnishings in the hotel were entirely destroyed.

The fire is believed to have started from defective wiring aided by a high wind.

Dr. Edna Carver and Blanche Foltz were overcome by smoke, but escaped serious injury. The seven guests of the hotel escaped.

## Order Prevents Ore Shipments

The new owners of the famed Austin Jumbo mine in the Awakening district will be served today with a temporary restraining order signed Saturday by Judge L. O. Hawkins, which prohibits them from milling or shipping any ore from the property until after they appear June 24 and show cause why the order should not be made permanent.

The order signed Saturday by Judge Hawkins, and which came into possession of The Humboldt Star a few minutes after its execution, specifically enjoins J. W. Wadley, H. L. Hunt and Sherman Hunt as added defendants in the suit of Walter E. Trent and others against George B. Austin.

J. W. Dignan and L. Schafer, attorneys for Trent, filed the petition asking for the restraining order and set forth the contention that the new operators are carrying on their operations in an unminerlike and extravagant manner and that unless restrained will remove moneys derived from the sale of ore and bullion out of the state. — Humboldt Star.

## TRAILERS MUST HAVE FEDERAL FIRE PERMITS

Although that new trailer may have all the comforts of home and despite the fact that a parked house trailer could be termed a building, a fire permit is necessary for those camping on national forest land.

This is the import of a federal ruling received by the outing bureau of the Automobile Club of Southern California.

So the trailerite setting out for a summer tour should obtain his 1937 fire permit and carry along the customary shovel and axe. Current permits may be obtained without charge from any ranger and at all Automobile Club offices.

Each person receiving a permit is required to furnish the make of car and current license number and to sign an agreement to abide by government rules and regulations while on national forest lands.

## TESTED RECIPE

**M**OST every culinary artist of local renown has one special dish for which she is famous. I remember mother's piece de resistance was



Strawberry Blitz Torte, a layer cake and meringue combination studded with fresh strawberries. When mother

was a girl, she was initiated into the Blitz Torte mysteries by an old cook who brought the recipe from Europe. Except that we have the modern advantage of a cake flour, which is twenty-seven times as fine as ordinary flour, this recipe is the same as that used by mother for making

### Strawberry Blitz Torte

1 1/2 cups sifted cake flour; 1 1/4 teaspoons double-acting baking powder; 1/2 cup butter or other shortening; 1/2 cup sugar; 4 egg yolks, unbeaten; 5 tablespoons milk.

4 egg whites; 1 cup sugar; 1 quart strawberries, crushed and sweetened.

Sift flour once, measure, add baking powder, and sift together three times. Cream butter thoroughly, add sugar gradually, and cream together until light and fluffy. Add egg yolks, one at a time, beating very thoroughly after each. Add flour, alternately with milk, a small amount at a time, beating after each addition until smooth. Spread in two greased 9-inch layer pans.

Beat egg whites until foamy throughout. Add sugar, 2 tablespoons at a time, beating after each addition until sugar is thoroughly blended. After all sugar is added, continue beating until mixture will stand in peaks. Spread in equal amounts on top of each layer. Bake in slow oven (325° F.) 25 minutes, then increase heat to moderate (350° F.) and bake 30 minutes longer. Spread with crushed sweetened strawberries. Cut in wedges for serving.
