No Fireworks In Mountains

Forest Ranger Anderson of the Charleston Park - Deer Creek forest areas, today issued a last minute warning to those who plan to visit the mountain areas during the Fourth of July holidays.

Mr. Anderson is emphatic in the declaration that no fireworks, firecrackers, cap-guns or explosives of any nature will be permitted in the mountain. And, while campfires under safe conditions will be permitted, all are given strict warning to see that such fires are entirely extinguished be ore they leave.

Recently, according to the Ranger there have been several cases where camp fires left burning have threatened to get beyond control and have been extinguished by the Ranger and his assistants only after struggle.

The Forest Ranger will maintain a checking station at the Deer Creek highway fork to inspect all cars and warn visi ors to the forest areas of the regulations adopted for protection of all.

Smokers are particularly warned to be sure your matches are broken and your your cigar and cigarettes entirely out before they are discarded.

There has been much carelessness recently in all these matters, according to Ranger Anderson , and now, because of the increased fire hazard those who ignore the regulations will be prosecuted and required to defend themselves in the courts.

He stated that the advocates of the original proposal were willing to start on payment of only \$1,000 in cash, the remaining \$2,000 for purchase of the five year year lease to be paid next year. He dwelt on the benefits which would accrue to the children by having the pool taken over by the city.

There was only very limited discussion of the problem, most of the members remaining non-committal. However, Ed Clark discussed the scheme of financing and declared that all such matters should be financed within the tax rate in the city budget.

Bryan Bunker also discussed some phases of the plan and President Frank Gusewelle declared the meeting adjourned without any action being taken on the swimming pool proposal.
