CARSON CITY - William Kelly Klaus has resigned as state director of unemployment compensation, and Governor Kirman appointed George W. Friedhoff as his successor, the appointment to take effect within a few days. So far as is known Governor Kirman never officially accepted Klaus' earlier resignation as liquor tax supervisor which may automatically return him to that position.

Friedhoff will take over the duties of unemployment compensation diposition as liquor supervisor.

It was indicated that the reason for the change was that the state tax commission desired to have Klaus return to the liquor supervision. Klaus told the United Press: "I was very happy as liquor supervisor and I shall be glad to turn over the unemployment work to Friedhoff."

Friedhoff was leaving his position as state director, Federal Housing Administration, because of the curtailment of activities here.
