# Winnemucca Has **New Power Line**

Electrcity from the Sierra Pacific Power Company system was turned into the distribution lines of the Western States Utilities Company in Winnemucca at 8 p. m. Saturday for the first time, Charles Fletcher, power company operating superintendent, reported.

The power from the western Nevada company will be used to supply increased demands in the Humboldt county seat. A diesel water generating system that has been used in Winnemucca for many years now will be used as a stand-by plant, Fletcher said.

The line used to supply Winnemucca stretches from Tungsten mine to the Getchell mine at Kelly Creek for a total distance of 64 miles. The Winnemucca tie-in is 26 miles from Tungsten.

Work on the line, built entirely by the Sierra Pacific company, started June 7. Actual construction was finished by July 21. Delay of arrival of transformers held up completion of the hookup until last week end, Fletcher explained.

The Western States Utilities company is operated as a separate unit by the Stone and Webster company, which also control the Sierra Pacific company, under a management contract lease that went into effect last fall. A. J. Shaver, formerly of Reno, is manager of the Winnemucca concern.
