Football Pool Heads Arrested

District Attorney Ernest Brown of Washoe county has taken steps to revoke the gambling licenses issued to Nevada Trust and Funding Company which is operating a football pool in Reno.

San Francisco police charge the concern with being a swindle and took into custody Charles A. Warren, said to be president of the company; Julian B. Ephraim, director, and Gene D'Artnur, said to be head collector for the pool in Sam Francisco. It is stated that they will be charged with grand heft.

District Attorney Brown of Reno said: "We understood that a gambling game was to be conducted in the state in compliance with the Nevada gambling act and if any violation of the lottery provision in the constitution can be proven I will prosecute the men to the full extent of the law."
