

## Club Banquets Notable Guest

The Business and Professional Women's Club, under direction of Mrs. Frank Beam, its president, entertained approximately 100 members and guests at a banquet at the Union Pacific dining room Monday evening in honor of Dr. Mary Hayes, director of the National Youth Administration.

Dr. Hayes spoke briefly on the problems which the NYA found confronting it. "It was our desire to create a movement which would be decentralized, with each state head authorized to work out the particular problem of that state," Dr. Hayes said. "Our second policy was not to duplicate existing agencies working along similar lines, but to supplement the work they are doing."

Revealing the work done since its organization two years ago, Dr. Hayes stated that there have been 165,000 young men and women interviewed by the NYA with the object of placing them in some line of gainful employment. Of these, we have succeeded in finding jobs for no less than 70,000, without displacing other job holders.

"Nevada is particularly fortunate in that there are two offices functioning splendidly in Reno and Las Vegas, and reporting many placements regularly. The Las Vegas project is under the direction of Mrs. Helen Scott who is associated with Mr. Stortroen of the federal employment office, and who has done a remarkable job," she continued.

Dr. Hayes paid tribute to the efforts of Miss Margaret Griffin, state director, who followed her, and explained that scores of young people are being maintained in the public schools who might not otherwise complete their education and that 19 students at the state university are receiving \$20 a month to aid them in completing their work there. Of this number, ten are from Clark county.

She declared that 77 per cent of the applicants in Las Vegas have been placed since the office opened in January.

Mrs. Frank Beam, president of the club, opened the meeting with an address of welcome and discussed the program of the B. P. W. C. which this year is devoted to "Our Town's Business," aiding in the solution of local business problems and to promote better business conditions in the various communities in which the clubs are organized.

She pointed out that there are nine clubs in the state with 270 members, and that the organization is national in scope.

Mrs. Beam introduced Miss Maude Frazier as toastmistress of the evening, and she introduced the distinguished guests, including Dr. Hayes, Miss Griffin, Mrs. Scott of the N. Y. A. movement, Mrs. C. S. Wengert of the P.-T.A., President Frank Gusewelle of the Rotary club, Bob Kaltenborn of the Kiwanis club, Fred O'Donnell of the Elks, Mrs. A. C. Grant of the Mesquite club, Mrs. Connolly of the Legion Auxiliary, Otto Kimball of the Chamber of Commerce, Wm. L. Scott of the American Legion, District Judge Wm. E. Orr, Mayor L. L. Arnett, District Attorney Roger Foley, Mrs. Cecelia Carey of the

child welfare department, and Paul Madsen, recreational director.

Mayor Arnett spoke briefly outlining the city's recreational program and paid tribute to the work of the recreational board during the past summer. He declared that juvenile delinquency had decreased by fifty per cent as a result of this program and complimented the board and Madsen on their work, pledging the city to a continuance of the movement in the future.

District Attorney Foley, in a few short words, declared that "There is no juvenile criminal problem in Las Vegas. The problem is the parents who fail to make a home for their children and spend their time in the keno parlors or bars of the city and pay no attention to the young people. If we met that issue we will solve the problems of juvenile delinquency."

Judge Orr complimented the club on its activities and its program, and joined in paying tribute to the recreational board for its work during the past few months.

Musical numbers interspersed with the addresses, included a violin solo by Mrs. Jim Carson, accompanied by Mrs. Herbert Waldman at the piano; a saxophone solo by Jim Vaughan, accompanied by Mrs. Waldman; and vocal solos by William Wallace, accompanied by Mrs. Fred Wilson.
