SYDNEY, Australia. - Gold production in Australia increased by more than \$8,000,000 for the year ended June 30, compared with that of the previous year. The value of the production was \$44,877,276, an interesting comparison with the years 1930-21, when it was worth only \$9,860,492.

The production is still increasing steadily, each month showing higher figures than the last.
