Liquor License Law Is Amended

The Board of City Commissioners on Monday last passed Emergency Ordinance No. 228, being amendments of various provisions of Ordinance No. 203, the Liquor Ordinance. The complete tet of the new law, which will become effective immediately following its publication for two weeks, will be found in another column of this issue of The Age.

The new amendments provide for, among others, the following chang-

1-Raise in the retail beer license From \$40 a year to \$100.

2-Permitting tables and settees in the taverns and booths, provided the partitions are not more than four feet in height and the sides

3—Permitting the sale or giving away of pretzels, jerkey, nuts, popcorn, cigarettes, cigars and tobacco.

4-Permitting the licensing of private clubs anywhere in the city with the approval of the city commission.

5-Raising the license for all those handling alcoholic beverages up to 30 per cent content from \$100 to \$180 a year. This affects restaurants, grocery stores, etc., which are selling beer and wines.

6-Restricting wholesalers sales in original containers sealed packages to retailers only and requiring the records of each sale to show the retailer's city license number.

7-Raising the family liquor store license permitting sales from one pint to one quart of spirituous liquors and one gallon of wines, from \$200 a year to \$300.

8-Repeal of section 22 which at present restricts one individual, firm or corporation to one tavern license.
