# **Reveille** Tells **Of Wells Fargo**

In last week's Reveille-Sun we reproduced a number of items about Austin's first Christmas day taken from the Reese River Reveille of December 26, 1863, seventy-four years ago. Among them was the announcement of a reward of \$500 offered by Wells, Fargo & Co. for the arrest and conviction of the thief or thieves who stole the treasure box from their office in Austin a short time before.

This early day express robbery interested many of our readers who have asked us to tell them more about it.

Unfortunately for the story, this theft was not an old-time wild west express robbery by masked bandits with long rifles but seems to have been more nearly the work of sneak thieves. 'The issue of this newspaper of Deecember 17, 1863, under the heading "Bold Robbery" has the following:

day before yesterday "Early morning, some time between 12 o'clock and daylight, the express box belonging to. Wells, Fargo & Co. which had arrived on the western stage that night was abstracted had into it and now they don't know from the office of the company and what they've got.

"The Overland mail agent who sleeps in the office had received the box when the stage arrived, as he is in the habit of doing, and placed it on the counter, but when returning to bed had neglected to fasten the door.


"When the agent came down early in the morning the box was gone. A few hours later, however, it was discovered in an old incline near the Oregon mine.

"The lid had been broken off, all the money extracted and the waybill destroyed so that the agents here were unable to tell the value of the lost property. None of the letters, a large number of which were in the box, seem to have been disturbed.

"The agent has since ascertained by telegraph that there was \$700 in money in the box. No clue to the perpetrators of this daring robbery has yet been found."
