# On Complaint

J. W. Squires Thursday afternoon swore to a complaint charging District Attorney Roger Foley with intoxication while in office.

The complaint was the outcome of the incident which occurred last Februray when Foley was injured when it is alleged, he made an attack on Squires while intoxicated.

That trouble was followed by a complaint by the district attorney's office on an embezzlement charge against Squires on which the defendant was held for trial in the district court last Wednesday. This case arose out of a conflict of interests in the proceeds of a check issued by the Tom Reed Mining Company of Oatman, to John Reed of Searchlight, in payment for ore shipped by Reed from the mine owned by A. M. Davis. Davis, upon whose order the check had been held up by the Tom Reed Mining Company, directed it released to Squires part of the money to be turned over to John Reed upon the compliance by the latter with certain conditions, the main condition being the reconveyance to Davis of a tax title interest held by John Reed, lessee of the property. Reed refused to comply with the conditions and Squires held the proceeds of the check pending settlement of the controversy according to the testimony in justice court. At the beginning of the hearing Squires placed the amount in dispute with Justice Earl to be adjudicated to the parties in interest.

The Justice of the Peace based his decision to hold the defendant for trial upon the theory that the Tom Reed Mining Company, makers of the check, were the only ones who had the right to attach conditions to the disposal of the \$264.75

which it represented. The complaint alleges:

That Roger Foley, then and there being duly elected, qualified and acting District attorney of said County of Clark, on the 17th day of February, 1937, in said County and State, became intoxicated, so that he was not at all times in a proper condition for the discharging of the duties of his office, among such duties being the trial of a criminal action entitled "The State of Nevada, Plaintiff, vs. Henry Krause, Defendant," which said action was then pending and being conducted in the District Court of said County.

"Contrary to that certain Act approved March 28, 1935 (Statutes of Nevada, 1935, page 272), and
