#### **Lincoln County Grand Jury Acts**

The Lincoln county grand jury seems to be stirring officialdom of that county to the very depths, according to reports printed in the Caliente Herald.

Following their first report made last week in which they returned four indictments against County Assessor Earl L. Mathews, the grand jury on Tuesday last presented a second report in which, in addition to some criticism of other officials, they demanded that the county commissioners request the imediate resignation of County Commissioner Fay Stewart.

The section of the second report dealing with the county commissioners is in part as folows:

BOARD OF COUNTY COMMIS-SIONERS: The Grand Jury has examined into the accounts and conduct of the office of County Commissioner of the Third District, and has found conditions of such extreme gravity as may make necessary further action by the grand jury in the event that the recommendations here made are not carried out effectively. The grand jury has in mind the condition of the public funds of Lincoln County and the expense of formal proceedings in the District Court. It is recommended that the Board of County Comissimoners of Lincoln County meet without delay, and that the Chairman of the Board requet the immediate resignation of Commissioner Fay Stewart and that a certified copy of the minutes of such meeting be submitted to this Grand Jury as the basis for further action as may be found necessary and proper. The Grand Jury has made a detailed examination of the accounts and conduct of one commissioner only. A detailed examination of each of the other county commissioners will be made with appropriate report to the Court upon the same.

Former County Assessor Mathews upon arraignment in the district court before Judge Orr, entered pleas of not guilty to each of the four indictments against him and trials were set for March 16, 17 and 18.
