Olen William Yates died at 9:25 Tuesday morning, March 22, 1938, ed several months ago. During the six weeks before his death he was a patient at Loma Linda Sanitarium where he was taken by Mrs. Yates who remained there with him until the end. Cancer, which involved the internal organs to such an extent that recovery was considered impossible from the time of the surgical diagnosis at the hospital, was the cause of death.

Funeral services are set for 3:30 this (Friday) afternoon at the Shaw Mortuary, San Bernardino, Cal., and will be attended by some of the close friends and associates of deceased in this city, including Miss Lois Craig and Mrs. Anna Moss, employees of the Pioneer T sneltiurI and Trust Company in this city, Mrs. ployes of the Pioneer Titile Insurance was associated with Mr. Yates in Sam Lawson Allye Lawson who mining business, Mrs. A. Mr. Yates, a native of Texas, was 56 years of age. He was long engaged in the abstract and title business, beginning in 1904 with the Panhandle Abstract Company at Austin, Texas. After being employed during 1906 with the Midland Abstract Company at Midland, Texas, Mr. Yates returned to the Panhandle Company as secretary and general manager, becoming president of the company in 1909, remaining in that position until

He was also manager of the Stephens Abstract Company of Breckenridge, Texas and for many years served as executive secretary of the Texas Abstract Association.

In 1926 Mr. Yates became associated with the Pioneer Title Insurance and Trust Company at San Bernardino, Cal., coming to Las Vegas in 1929 to establish this branch of the business, which he operated with marked success until he was compelled to enter the Sanitarium.

During his residence in Las Vegas, "Q. W.", as he was familiarly called, took a high place as a leader in civica and fraternal affairs. He was a member of Vegas Lodge No. 1468, B. P. O. E.; of Vegas Lodge No. 32, F. & A. M.; Las Vegas Rotary Club, Las Vegas Chamber of Commerce, Clark County Chapter American Red Cross and Clark County Fish and Game Association, to all of which he gave unselfishly of day. his time and money, performing many acts of outstanding public

Anderson Case Award Affirmed

The United States Circuit Court of Appeals sitting in San Francisco has handed down a decision in the Anderson case affirming the judgment of Judge Frank H. Norcross, who tried the case in the United States District court in this city.

The suit was brought by the plaintiff, Anderson, to recover for damages received when he was struck by a car driven by an employee of the Los Angeles Bureau of Power and Light.

Judge Norcross gave plaintiff judgement on Thanksgiving Day, 1935, in the amount of \$21,904, which now, with added costs and accrued interests amounts to approximately \$27,000.
