City Repudiates Municipal Power

Following the report of the advisory City Power Board, the city commissioners expressed the belief that it is unwise under present conditions to proceed with either the purchase or construction of a municipal power distributing plant, thus putting an end, at least for the present, to the municipal power agitation which has disturbed the city for the 'past three years.

The board voted to reject the PWA plans which had been proposed for partial financing of the municipal power project, and to "permit the matter to rest until conditions seem more favorable for the successful consummation of the project should the community still desire to enter upon such an undertaking."

Among the 149 young men and women who will graduate from the State University next Monday, May 9, will be Charles S. Doherty, son of Mrs C. C. Boyer of Ely and grandson of Mr. and Mrs. Charles P. Squires of this city.

TWENTIETH EPISCOPAL SYNOD Bathing Beauty Footprinters OF PROVINCE OF THE PACIFIC **CONVENES HERE NEXT TUESDAY**

For the first time it its history the Synod of the Province of the Pacific, which comprises the fourteen dicceses in the states of Washington, Oregon, Idaho, California, Arizona, Utah and Nevada; also those in the territories of Alaska, Hawaii and the Philippines, will hold its annual session in Nevada. This is expected to be the largest representative religious gathering to be held in the state.

The annual session, which is the 20th, is scheduled to meet at Las Vegas on Tuesday, Wednesday and Thursday, May 10, 11, 12. The Presiding Bishop of the National Church will be the c hief figure. This will be his first visit in the West and the first Synod of this Province at which any Presiding Bishop has paid a visit.

The Most Reverend Henry St. George Tucker, the Presiding Bishop, is a direct descendant of the Washington family. His father was bishop of Virginia, and he himself is the present Bishop of Virginia. For 20 years he was stationed in Japan, for 9 of those years as President of St. Paul's University and for 13 years as Bishop of Kyoto.
