

Unlimited Gets Publicity Head

RENO, April 30-The Board of Directors of Nevada Unlimited, headed by John S. Sinai, president, today announced the appointment of J. O. T. Cartwright, formerly of San Francisco, as managing director of the organization formed last year to publicize and advertise the entire state of Nevada.

Cartwright is widely known in California and other Pacific Coast states and is considered one of the outstanding publicity and promotion men of the west.

He is not only widely known as a publicist but also as a newspaperman of many years experience on papers in San Francisco, Los Angeles, Denver, Washington, D. C., and New York City.

Nevada Unlimited's new managcity director of Transcontinental & Western Air Inc., with headquarters in San Francisco and he organized the Santa Fe Railway's compaign to obtain intra-state stage permits from the California State Railroad commission.
