Ickes today announced a modification of the administrative setup of the Bureau of Reclamation's Central Valley project in California in preparation for commencement of large-scale construction.

Mr. Ralph Lowry, who has served as Director and Construction Engineer since 1935 of the Boulder Canyon Project, is being transferred to the Central Valley Project to become Construction Engineer of Shasta Dam. with offices in Redding, California
