

#### New Skyline Trail Is Thriller



ITORSES have no sense of height. And that is just as well, for the II new skyline trail which has been laid out in Jasper National Park, in the heart of the Canadian Rockies, lies for three miles on the topmost edge of a ridge more than 8500 feet high. It is a mile down to the valley floor from the top of the ridge and the shale slopes shoot downward from both sides of the trail at an angle of 45 degrees. On a clear day it is possible to see more than 100 miles from this spectacular trail, even down into the Columbia Icefield region, the largest glacial area south of the Arctic in North America.
