Nevada Livestock Ranges Are Good

Nvada's livestock ranges were in better shape on May 1 than on that date during the average of the last ten years, according to a report to the University of Nevada agricultural extension service by the U.S. bureau of agricultural economics.

Abundant rain and snow throughout the state during April sitmulated plant growth, Frank Andrews, head of the Salt Lake City office of the bureau, explained, and the late spring and summer ranges were reported beginning to develop nicely.

Pasture conditions, he stated, also showed considerable improvement during April.

Cattle have wintered well, the federal statistician reported on May 1, and have not required as much feed as usual in most cases. Winter losses are said to have been light, with prospects for a good calf crop. Cattle, also, were in better condition than a year ago, as well as above the ten-year average for May 1.

By the end of April, practically

lamb crop will be comparatively high as a result of the favorable conditions throughout the winter."

Conditions in the various parts of the state on May 1, as reported by the U.S. bureau, were as follows:

Northwest-precipitation has been unusually great during the past several monts. The higher summer this Court a document purporting to range areas are still covered with considerable snow. A good growth of feed is expected, however, as soon as warmer weather develops. Livestock are mostly in good flesh and winter losses have not been excessive.

> Northeast-condition of range improved during the last month. Precipitation has been enough to insure a good growth of feed. Livestock is in good condition generally and show very little loss to

Southern-most of the live stock have now been moved from the winter ranges in the southern part of the state. Rangs have been good during the past winter and precipitation has fallen frequently enough to provide stock water and soil moisture. As a result of this condition, livestock losses have not been great.
