BAND CONCERT BY CRACK ALADDIN TEMPLE NOBLES FEATURE SATURDAY NITE

Nobles of the Mystic Shrine, enroute to the Shrine Convention in Los Angeles, will "take over" Las Vegas and Boulder City today and tomorrow.

Special trains will begin arriving in Las Vegas tomorrow morning at 7 o'clock. The nobles will be taken to Boulder City where they will be shown the dam, including a boat trip on Lake Mead.

One of the features of the Las Vegas visit, will be a band concert by the crack Aladdin Shrine band, from Columbus, Ohio. The concert will be given in the Union Pacific park in the evening. All Shrine units will stay in Las Vegas for several hours.

The first contingent of Shriners arrived on train 21 yesterday and were taken to Boulder City by bus, returning to Las Vegas in the evening in time to leave on train 7 for Los Angeles.

Tonight on train 7 units from Hartford, Conn., Bridgeport, Conn. Springfield, Mass., and Albany, N. Y. will arrive. This contingent will stay over night at the Sal Sagev hotel and be taken to the Dam Saturday morning.

Saturday morning at 7 will see the arrival of two special trains bearing nobles from Aladdin Temple, Columbus, Ohio. These special trains will go directly to Boulder City, returning to Las Vegas at 3 in the afternoon. The trains will depart for Los Angeles at 11 p.m.

Saturday trains 5 and 21 will bring in special cars with shriners from Boumi Temple, Baltomore, Md., Zenobia Temple, Toledo, Ohio, Rajah Temple, Reading, Pa., Lulu Temple Philadelphia, Pa.

Merger of Bus Lines Is Denied

The Interstate Commerce Commission rejects the merger into one large transcontinental bus line between the Burlington Trailways, a subsidiary of the Burlington railroad and the Interstate Transit Lines, a subsidiary of the Union Pacific and the Northwestern railroads. J. Edward Davey, chief of section of finance, bureau of motor carriers, interstate commerce comission filed a report prohibiting this merger, stating that competition would be restrained.
