ELKO, Nev. — Properties owned in the Gold Circle district by the East Standard Mining Co., including the Sleeping Beauty, Queen, Bamburger and Macy mines, have been optioned by G. L. Buck and Percy Collins of San Andreas, Cal. Nego iations are also reported proceeding for the Warren holdings and extensive placer deposits.

Extensive bodies of low grade ore have been developed in the East Standard group and comprehensive churn drilling of the area is planned. Construction of a large mill is ontemplated if prospecting discloses a satisfactory tonnage of commercial ore. Buck and Collins are reported to represent eastern capital.

California interests have taken an ption on the Bauer, Ellis and Mader placers near the mouth of Midas Canyon in the upper section of Squaw valley. Prospecting with a thurn drill is scheduled shortly. Preliminary sampling was satisfactory.

The Gold & Silver Circle Mines Co. is running its mill at capacity in material from the waste dump at the Elko Price mine. About 25 - 000 tons sampling \$8 a ton, are reported available. The plant has a capacity of 75 tons.
