

Martin Leader Of Republicans

The Republican County Convention for Clark County was opened by County Chairman Art Harris at the Court House Tuesday morning at eleven o'clock, with a large number of enthusiastic delegates present.

The most important business of the day was the choice of Dr. Roy W. Martin as local head of the County Convention and later being named by unanimous vote as Chairman of the Republican County Committee for the coming two years. Prior to his nomination and election Dr. Martin was described as having been for more than thirty years "one of the most loyal, enthusiastic, efficient and hard work-

ing Republicans of Clark county." Effie Deadrich, in recognition of her excellent work, was reelected secretary of the county committee and A. S. Henderson, who has served for many years as treasurer of the committee, was reelected to that post.

Art Harris, who has served as chairman of the Republican County Committee for the past two years was given a vote of thanks for his loyal and efficient services, and a resolution expressing the appreciation of Clark County Republicans for the good work he had done during the difficult years of his administration, ordered sent him.

A vote of thanks was given to Justice of the Peace Marion Earl for his courtesy in allowing the Republican County Convention to meet in his office in the court house.

Farm Incomes Show Variation

Nevada's first camp especially for farm women will be held at Lake Tahoe July 10 through 13.

Arranged through the University of Nevada Agricultural Extension Service and the Nevada State Farm Bureau, the camp is expected to assemble rural women from most of the counties of the state. Already indications are that Washoe, Lyon, Churchill, Douglass, Elko, Ormsby and Pershing counties will be represented.

Skyland, former boys' camp near Zephyr Cove, will be used for the outing, as for the State 4-H Club camp and other agricultural camps during the summer months.

While the chief purpose of the camp is to give the farm women of the state a wholesome vacation, plenty of activities will be arranged for the more ambitious ones, according to Miss Gertrude Hayes of the Extension Service staff, who is

in charge of the outing.

Swimming on the Skyland beaches, hikes through the pines and along the shores, singing under the direction of Mrs. Florence Bovett of the Nevada State Farm Bureau, stunts, and evening campfire assemblies are on the program, she said.

For those who need anything additional to keep busy will be classes in handicraft work, especially in wood, copper, and leather. The women will make articles which they can take home with them.

July 10, the opening day at the camp will be "family day," Miss Hayes states, when the fathers and the children will bring the campers to Skyland and stay for a picnic lunch, camp activities, and the remainder of the day.

Registrations for the camp are being arranged through the extension agents in the various counties of the state, Miss Hayes has announced, and will close July 2.

Hints to Gardeners

In the Rock Garden

WITH the rush of the spring and early summer planting season over, this might be a good time to consider rock garden problems.

Although most annual flower seeds should not be planted until next spring, the time is approaching when the garden may be economically dressed up by planting seeds of perennial favorites for early bloom next spring.

This is, moreover, the time of year when many gardeners find time to build that long desired rock garden, or to rearrange the old one. Discussions here may be helpful to them in their planning.

Selection of flowers can make or break the rock garden. It is important to select only those plants that grow among rocks in their native haunts and those that seem to belong among stones. They make the garden look more natural, and they also thrive better under rock garden conditions.

Use judgment in placing the various plants. Creeping plants should be allowed to make carpets of color in the larger soil pockets. Erect plants of varying heights are appropriate in any of the flat spaces. Plants that trail should be allowed to droop over the face of the rocks; or they may be placed at the top of a bank or wall.

In smaller crevices, tufted plants with rosettes of foliage and short flower stalks are suitable. Ordinary garden and bedding plants should be eliminated from consideration for the rock garden.

Most true rock plants grow less than ten inches tall. Use these low growing perennials and annuals mostly. Toward the back, however, and for accent here and there, use some of the medium and taller growing annuals considered suitable. They will give a pleasing contrast in size.

As for color, use plenty of white, to set off the tinted blossoms.

Dr. Martin made one of his characteristic, vigorous talks, in which he declared that the Republican party is on its way back, rapidly recovering from the landslide of 1932. He expressed the belief that the Republican party would, during this coming election and the one two years hence, return to the position of National leadership which it had held for many years.
