Conference At **Phoenix Helpful**

C. F. DeArmond, member of the Colorado River Commission, made a brief report to the Chamber of Commerce Tuesday morning of the proceedings of the Colorado River conference held at Phoenix last week.

Mr. DeArmond stated that the object of the conference was to urge upon the federal government the desirablity of a treaty with Mexico defining the interests of each nation in the waters of the rivers crossing the international boundries, notably the Colorado River and the Rio Grande.

Representatives of Texas, interested in the Rio Grand problem were present at the conference, and stated that at times the flow of the Rio Grande was so small along the Texas border that there was not enough water to irrigate the crops, but that, in terms of annual flow there was ample water for both Mexican and Texan lands, requiring only the building of storage dams at points along the border. They urged that an attempt be made to provide by treaty for the building of starage dams along the border and for the defining the rights of both countries in waters flowing across the International boundaries.



Valley Power Line Assured

Rapid progress is being made in the preliminary work in preparation the construction of the power distribution system to provide electrical power for the Moapa and Rio Virgin valleys, according to H. W. Crozier, electrical ngineer for the Overton Power District.


Last Sunday a meeting was held at which representatives of the upper Moapa Valley met with Mr. Crozier, W. H. Lyon and other off cials of the power district, resulting in the decision to include the upper portion of the Moapa Valley in the district. Those repersenting the upper valley were Messrs Geo. Baldwin, Arthur Doty, Wm. Livingston, C. B. Phillips, Guy Doty, C. A. Murphy, McKay and Merrifield.

There will be 86 miles of power line in the system, as follows:

Lincoln County Power District main transmission line to Glendale, at 89,000 volts, 24 miles.

On the whole the Phoenix conference was helpful and encouraging, Mr. DeArmond stated.



Several miles of the telephone line of the Borax Company, between Death Valley and the Junction, is now being re-aligned, and new poles are being set. This is in preparation for the reconstruction, by state highway forces, of several miles of the state secondary highway.

The new road will begin at the Monumnt line, 17 miles from the Junction, and extend up toward the Junction for a distance of something like eight or ten miles. This improvement has been planned by the state for some time, and will, when completed, eliminate several sharp, narrow, dangerous blind turns.

One of the difficult, tedious, tiresome, side trips, from the Valley, in the past, was that leading from the main highway in the north end of the Valley, up to Scotty's Castle. This stretch of rough road has, in the past, deterred many tourists and travelers from making the trip and inspecting this world-famous structure. Just within the past few months, however, under supervision of the Park highway officials, this piece of highway has been improv- and through the famous Castle.

highway extending from Beatty, in a southerly direction, to the Nevada-California state line, is now being surfaced, and will soon be ready for public use. The alignment of this road has been changed slightly, as it is now being constructed. The present road leads out of Beatty in a southerly direction, for a short distance, but at the outskirts of Beatty, instead of turning to the west and following the old railroad grade, up over heavy grades, into and thru Rhyolite, the road continues almost due south from Beatty. This avoids heavy grades and also cuts off quite a bit in distance, making the road, not only of evener grade, but considerably shorter. This new road joins the old south of Rhyolite, and continues into Death Valley.

This link completes the paved road from the Nevada state highway leading from Reno, Tonopah and Goldfield, through Beatty, running in a southerly direction, thus forming the north entrance into Death Valley over Daylight Pass. The construction work is being done by the Jack Casson Contracing Company of Hayward, California.

Wednesday officials of the Overton Power District No. 5, met with Ed. W. Clark and C. F. DeArmond, members of the Colorado River Commission and J. H. Buehler, chairman of the board of the Lincoln County Power District No. 1. Those representing the Overton District were Clarence A. Lewis, chairman, John E. Whipple, secretary; H. W. Crozier, project engineer and W. H. Lyon, project superintendent.

The object of the meeting was preliminary to the settlement of two problems; first, a contract with the Lincoln County District for the transmission of power over their line from Boulder Dam to the point from which the Overton District line will take off; second, a contract with the state of Nevada, represented by the Colorado River Commission for the sale of power from the Nevada allocation at Boulder Dam.

Project Engineer Crozier reports that the Rural Electrification Bureau at Washington has allocated money to the Overton District, a portion of which has already been received, for the preliminary work of the Overton Power District.
